LIST OF ACCEPTABLE DOCUMENTS

Effective November 14, 2016; Revised rule 18.19.5.12 NMAC provides that the documents listed below are acceptable as proof of (A) Lawful Identity and Age, (B) Identification Number and (C) New Mexico Residency for non-commercial driver's licenses and Identification Cards. Please see MVD Drivers Manual for more details.

Provide certain documents from section A, B and C below to your local MVD office to get a New Mexico REAL ID. Your documents must be original or certified copies. Photocopies, notarized photocopies and non-certified copies are NOT acceptable. If you lack any of these documents or need to make corrections to your name, identification number or physical address, reference the Resource Guide on the second page of this document to help direct you.
